## **Hall of Fame Instructions**

- 1. There are two separate packets that are used to apply for consideration for entry to the Nevada State USBC Association Hall of Fame. The first is for a **meritorious** application and the second is for **superior performance**.
- 2. The form may be filled out online but must be signed and mailed to the address listed on page one of the nomination form.
- 3. You may nominate a bowler in either one or both categories. If you do not use both, please discard the unused form.
- 4. You must complete a narrative page for each application. Please put some thought into the completion of the narrative. Often it is the only thing that separates two equally qualified candidates and, if there is a limit on nominees for a given year, this may well be the only deciding document.
- 5. The completed nomination form must be submitted to the address noted on the bottom of page 1 of the application **not later than Feb 1**<sup>st</sup> of the current year. Late entries will be placed in a file for the following year.
- 6. Non-selectees whose applications are not updated are automatically considered for four additional years. After this time a new application will be required for additional consideration. Updated applications are considered for five years from the date of update.
