Hall of Fame Application – Meritorious Service

Any member of the Nevada State USBC may nominate one or more bowlers by submitting the appropriate application form (Superior Performance or Meritorious Service) to the Hall of Fame committee. Nominations for any year may be submitted to the Hall of Fame committee at any time but must be submitted no later than April 1st to be considered for that year's election.

Non-selectees whose applications are not updated are automatically considered for four additional years. After this time, a new application will be required for additional consideration. Updated applications are considered for five years from the date of update.

In addition to the nominations for living members, posthumous nominations are acceptable.

The forms may be filled out online but must be signed and mailed to the address listed on page one of the nomination form.

Bowlers may be nominated in both categories.

Please put some thought in to completing the narrative page as often it is the only thing that separates two equally qualified candidates.

Nominating Criteria:

Examples of the criteria that should be included in the application are:

- a. Years of service as a NV state president, officer, director or Association Manager
- b. Multiple years of participation in or support of NV state tournaments.
- c. Serve as a representative of the NV State USBC to the USBC National Conference
- d. Serve as a committee chairperson or have been responsible for the adoption of an association program or special project of the NV State Association.
- e. Outstanding service in the promotion of bowling.
- f. Local Nevada Association service or USBC National service (offices held, committees served, etc.) as well as special honors such as local hall of fame recipient, Industry awards, etc. will be considered.

Must demonstrate good sportsmanship and integrity both on and off the lanes, and not have ever had their USBC membership suspended.
