## Hall of Fame Application – Superior Performance

Any member of the Nevada State USBC may nominate one or more bowlers by submitting the appropriate application form (Superior Performance or Meritorious Service) to the Hall of Fame committee using the mailing or email address located at the bottom of page 3. Nominations for any year may be submitted to the Hall of Fame committee at any time but must be submitted no later than April 1<sup>st</sup> to be considered for that year's election.

Non-selectees whose applications are not updated are automatically considered for four additional years. After this time, a new application will be required for additional consideration. Updated applications are considered for five years from the date of update.

In addition to the nominations for living members, posthumous nominations are acceptable.

The forms may be filled out online but must be signed and mailed to the address listed on page one of the nomination form. Please email a head and shoulder picture to the email address on page 3. This will be included in the voting packet.

Bowlers may be nominated in both categories.

Please put some thought in to completing the narrative page as often it is the only thing that separates two equally qualified candidates.

### **Nominating Criteria:**

Those NSUSBC members or former Nevada State predecessor organization members who meet the following qualifications:

- a. A candidate must have been a member of USBC for a minimum of 20 years and must have been a member of Nevada State USBC for a minimum of 15 years (does not have to be consecutive)
- b. Must be a minimum of 40 years old by June 1<sup>st</sup> of the current bowling season.
- c. Should have outstanding achievements in all phases of bowling such as:
  1. State Tournaments (Can include Youth Tournaments)
  2. USBC National Tournaments
  3. USBC Masters/Queens
  4. Local Tournaments
  5. Other nationally certified tournaments
  6. League Performance – performance that is worthy of a superior status based on your bowling career, location and the time frame bowled. For example, 10 seasons or more where the bowler has established a 190 plus average for women and a 220 plus average for men, with a 60-game minimum.
  7. Distinguished promotion of the Sport of Bowling
- e. Must demonstrate good sportsmanship and integrity both on and off the lanes, and not have ever had their USBC membership suspended.
